**Subject : Setting up of an "Advisory Committee" to examine and recommend for the Scheme of Interest Subsidy for Housing the Urban Poor (ISHUP) -reg.**

2. The Committee will review the existing scheme of ISHUP, analyse the causes for its slow off-take and suggest practical modifications to make the scheme widely acceptable with the ultimate objective of channelizing flow of credit to the EWS and LIG beneficiaries under which category there is enormous shortage of housing.

3. The admissibility of TA/DA in respect of official members for attending the meeting of the 'Advisory Committee' shall be governed by the respective service rules applicable in their case and borne by the concerned Department / Organisation to which they belong.

4. The admissibility of Room Rent , conveyance ,TA/DA etc. in respect of **non-official members** for the meeting of "Advisory Committee" , constituted as above shall be as follows :

- (a) Reimbursement of rent in any State Guest House or for single room in medium range ITDC hotels like Lodhi Hotel , Qutub Hotel , Janpath Hotel , Ashok Yatri Niwas of State Government run Tourist hotels/hostels or residential accommodation provided by registered societies like India International Centre and India Habitat Centre to the outstation **non-official members** subject to provisions contained in Appendix 2 of FR &SR Part II.
- (b) Dearness Allowance : At a flat rate of Rs. 150 per day if the member stays in a hotel and Rs. 100 per day if the member does not stay in a hotel to the outstation **non-official members** subject to provisions contained in Appendix 2 of FR &SR Part II.
- (c) Conveyance Allowance: Actual conveyance hire charges subject to a ceiling of Rs. 75/- per day in respect of **both local and outstation non-official members**.
- (d) A sitting fee of Rs. 2000/- per meeting will be paid to the outstation **non-official members** .
- (e) Air-Journey : The outstation non-official members can travel only by the **Economy Class of Indian Airlines** and to and fro airfare from their normal place of station to the place of meeting will be reimbursed.

5. The expenditure on this account shall be debited to the A&OE head of Interest Subsidy for Housing the Urban Poor (ISHUP) for the respective year . The Finance Division has given concurrence to the proposal vide their Dy.No. 579/D-4/FD/11 dated 13/10/2011 .
